2. **Study Session: General Plan Update**

This is an information item intended to provide an overview of proposed draft land use designations for the General Plan Update. No action is required. 3. **Request for Removal of Crosswalk at Walker Street/La Luna Drive**

It is suggested that the Traffic Safety Committee recommend the denial of a request to conduct a Traffic Study at the intersection of Walker Street/La Luna Drive in the amount of \$2,560.

4. **Request for a Traffic Signal Installation at Walker Street/Bransford Drive**

It is suggested that the Traffic Safety Committee recommend the denial of a request to conduct a Traffic Signal Warrant Study at the intersection of Walker Street/Bransford Drive in the amount of \$4,500.

5. **Installation of Handicapped Parking on Public Streets**

It is suggested that the Traffic Safety Committee recommend to the City Council to approve the proposed City Policy for the installation of handicapped parking on public streets.
