#### **PRESENTATIONS**

#### ORAL COMMUNICATIONS

Gary Pickett, 5211 Del Serra Circle, addressed the City Council regarding his opposition to receiving a ticket on the Martin Luther King Jr. National Holiday.

Police Chief Nuñez responded that there was a training discrepancy with the new Parking Enforcement Officer and that the Police Department will be cancelling all parking tickets issued for street sweeping on that holiday.

12. Streamlining Development Review in La Palma via Development Committee Dissolution

Community Development Director Dumhart gave the Staff Report.

Council Member Questions and Comments:

Discussion ensued regarding the difference in cost being Staff time involved preparing for a meeting; the duties of Committee members; the minimal amount of meetings over the past couple of years; Council Member Goedhart's previous suggestion to have the Development Committee be the Planning Commission;

the desire for resident participation in City matters; the struggle to recruit members every year; current lack of members to have a quorum; asking current Development Committee Members their opinion on the Committee's dissolution; and support for citizen committees.

Council Member Goedhart made a motion to appoint the Development Committee as the Planning Commission.

The motion failed for lack of a second.

Further discussion ensued regarding residential reviews requiring Development Committee (DC) review and approval being on hold until a decision is made; that there are enough applications to fill the empty DC seats; the upcoming interview schedule for applicants; that requiring Development Committee review for remodels was part of the 2003 Zoning Code rewrite; City Council's understanding of reduced staff in the Community Development Department; that public input is usually given to the final reviewing body; opposition to DC dissolution; and that dividing the DC duties amongst Staff and the Planning Commission streamlines the review process entirely.

Mayor Shanahan made a motion to have Community Development Director Dumhart interview current Development Committee Members regarding their opinion on the DC Dissolution.

Council Member Goedhart made a substitute motion to ask current Development Commission members if they would be interested in serving as the Planning Commission.

# <u>COUNCILMEMBER AB1234 REPORTS, REPORTS FROM CITY-AFFILIATED</u> COMMITTEES, AND COUNCIL REMARKS

**Council Member Goedhart** attended the OCFA Finance Committee meeting; the OCFA Special meeting; and asked for an update on the Southern California Edison Street Light Audit.

City Manager Volmert responded that the City is in receipt of the audit and evaluation; that the Public Utility Commission (PUC) process is different when working with small cities; that details in the audit will be included in the upcoming energy assessment; and purchasing agreement models will be under review along with the length of the process. She closed by reporting that the City Council will receive a report on the matter in March from Climatec and noted the details of Climatec's agreement with La Palma.

Council Member Goedhart continued his remarks by stating his queries for the Mid-Year Budget Review as follows: concerns for numerous funds with negative balances such

as Measure M, the water/sewer fund, the insurance fund, the employee benefit fund, internal service funds, vehicle maintenance fund, etc. He closed by stating his concerns for Police Department budget overages and various utility and other accounts being over what was budgeted, and that he expects these matters be explained at the upcoming mid year budget review.

**Council Member Charoen** had nothing to report.

**Council Member Hwangbo** attended the OCVCD meeting and asked how the City is addressing water conservation during this drought.

Community Services Director Belknap responded that since the December 2008 City declared "Stage 1 Water Emergency", the City has been conserving water and that Staff is currently reviewing the "Smart Sprinkler" systems for the City and ways to communicate with residents on water conservation.

City Manager Volmert also reminded the City Council that they recently approved the HERO program - allowing residents another financial outlet to make water and energy conservation improvements to their homes.

Council Member Hwangbo continued by reporting that the La Palma United Methodist Church is inviting City Staff to an upcoming appreciation lunch on January 28, 2014.

Council Member Goedhart remarked that previously, the City's water usage was not fully metered and inquired if that has been resolved and if not, that it be looked into.

Community Services Director Belknap indicated that he did not believe so and that he will research the issue and return to the City Council with a response.

**Mayor Pro Tem Kim** attended the OCSD meeting; the City Council Goal Setting session; the OCSD Labor Negotiation Selection Committee; the Los Alamitos State of the City luncheon; and the City Council Special Meeting.

Mayor Shanahan attended the City Council Goal Setting Session.

#### **CITY MANAGER REMARKS**

City Manager Volmert attended the Los Alamitos State of the City Address and announced that she would be out of the office on January 24, 2014.
