## REGULAR ITEMS

### 2. **Request for Additional Parking Restrictions to the No Parking Area of Crescent Avenue (5551-5569 Crescent Avenue)**

It is recommended that the Traffic Safety Committee recommend additional parking restrictions, consisting of painting the curb red, from the driveway entrance at 5551-5569 Crescent Avenue, to the existing "No Parking" sign west of the driveway (approximately 30 feet).

### 3. **Request for a Multi-Way Stop at the Intersection of Santa Margarita Lane and Del Este Circle**

It is recommended that the Traffic Safety Committee take the following actions:

1. Receive and file the Community Center Parking Lot Analysis
2. Recommend the following:
  - a. Recommend that the City Council deny the request to install a multi-way stop control at the intersection of Santa Margarita Lane and Del Este Circle; and
  - b. Recommend that the City Council approve the installation of centerline and edgeline striping to aid in reducing vehicular speed along Santa Margarita Lane.

### 4 **Community Center Parking Lot Analysis**

It is recommended that the Traffic Safety Committee take the following actions:

1. Receive and file the Community Center Parking Lot Analysis

2. Recommend the following:
  - a. Restriping of the northern-most driveway to two (2) 15-foot lanes: and
  - b. Install an ADA compliant disable access ramp at the southerly-most crosswalk located at the west side of Walker Street.
